Workgroup Reporting

- All Hands In; Crystal Francis & Imani Angela Rose
 - Operationalize standard procedures for ECAC—amended bylaws & operations manual (will discuss more later)
 - o Roles of an Executive Committee
 - Will finalize by-laws by next meeting
 - o Meeting w/key stakeholders: Mayor Scott, Dr. Dzirasa, Dr. Santelises
- Strong Backbone; Khalilah Slater Harrington & Tisha Edwards
 - Recommends below as a guideline for ECAC advocacy. Additional recommendations include following the ECAC approved advocacy guideline for a period of 12 months. After that period, the workgroup will collect feedback from the ECAC regarding effectiveness, make necessary changes and bring those changes to the full ECAC for review/approval.
 - ECAC should join MFN's public policy group

- The ECAC may want to find 1-3 pieces of legislation that it can support during legislative session because it moves too fast for the coalition to make decisions about what issues to support while session is in progress
- ECAC members (individual organizations) are encouraged to take action
- ECAC members (as individuals not representing ECAC or their organizations) are given opportunities to provide testimony and/or other ways to support legislation
- If at least 25% of ECAC organizations are aligned/in agreement action can be taken under the name of ECAC with only signatories of members comfortable with that issue. I.E.- letters of support would clearly outline which members are providing their support. Language may include "Member of the ECAC" as to not imply we are speaking for everyone.
- ECAC met w/Prenatal to 5 Impact Collaborative to help inform their recommendations for how MSDE should spend the \$500M for Early Childhood from the ARPA
- Smart Thinking; Lieny Jeon & Margo Candelaria
 - Working w/Children's Cabinet EC workgroup to produce report re. 0-5 involved w/publicly funded programs; also working w/ECDC
 - o Will present findings at next workgroup meeting & to this full group
- Open Heart; Angelique Jessup & Denine Rafus
 - o Main focus on taking steps towards an ECAC website
 - o We'll be voting on some questions around the website

- Early childcare systems report
 - PSA: Interview providers & look for how providers align/where there are gaps
 - o Family/Community Engagement—focus groups and interviews w/families
- Draft will be ready by November 2021

Pre-K Enhancement Grant: Crystal Francis

- All about recovery efforts for students
- Supporting 3-4 year olds in summer and Fall
- 8 day turn around to write the grant;
- 70% has to be spent on direct services
- Fund summer programming—never done district wide for rising pre-k & K students; Judy Centers have done this
- 5 week program to start after July 4th—Mon-Thur; ½ day, in person, small groups w/teachers they'll have next year
- 40 schools expressed interest, but not sure if staffing will be aligned
- Will use ELA to track progress pre and post
