# Welcome and Opening Remarks from Co-Chairs, Crystal Francis & Imani Angela Rose

#### Workgroup Reporting:

- All Hands In; Crystal Francis & Imani Angela Rose
  - Working on Strategic Refresh
  - Working on getting some grant funding
  - Want to ensure they're utilizing the brain power of ECAC members!
  - Work with Hyve this year is going to be more in depth
    - The EC landscape has shifted a lot, so want to make sure ECAC is being responsive to those changes
    - They're going to work with us for 3 months, starting with leadership in August to solidify strategic priorities
  - Sending out an organizational survey to see what work ECAC members are doing in their organizations to see where there is alignment or opportunity for ECAC to support (Strong Backbone is going to look at that)
- Strong Backbone; Ashley Bush & Tracy Harris
  - Looking at training opportunities for child care providers—prioritizing trauma informed care and domains of learning as we head into mixed-delivery implementation
  - External facing event for families to understand about early childhood entities
    Don't want to duplicate efforts of other organizations
  - Collaborating with All Hands In about what actionable goals Strong Backbone can have
  - ECAC was at the BCCCRC's child care appreciation event
    - Christina Peusch presented to workgroup about 2024 Legislative Session bills re. child care that passed

- Smart Thinking; *Hilary Roberts-King* 
  - Martha Holleman presented information about how to expand the 2020 BERC landscape
  - A lot of dialogue about we'd like to do and what the road blocks are
    Examining policy roadblocks
  - Examining (1) workplace issues for childcare providers; and/or (2) collecting data from private childcare providers
    - Group voted to look at regionally specific workplace issues—using Mayor's Office of Children and Family Success funding to get that completed
- Open Heart; Yolanda Jenkins
  - Working with consultant to do Family Engagement strategy to support ECAC with ongoing family engagement—Spark Solutions Consulting, have a contract in place
  - Will have a plan in place to propose to ECAC by August
  - Consultants will work on survey for families to determine how families get their information, to inform the family engagement plan
    - Survey will have a tight turn around, so we need ECAC to send it out!!
    - They will also do focus groups with ECAC members to know how members are already engaging families to take that into account—to not duplicate efforts, but rather tap into the eco-system
    - Milestones Document: printed and mailed out to ECAC partners
      - Requested feedback
        - Request for Spanish Version—working on getting the translation this month, to have printouts by the end of next month

# Mixed Delivery Hoc Workgroup Update; Imani Angela Rose & Crystal Francis

- Working with a consultant
- Will be taking a break for the summer

  - Discuss legislative changes
  - Issues with childcare credentialing
- City Schools submitted their Blueprint Implementation plan in May
- 4 buckets of work

- o Braided funding to support mixed delivery
- Engaging Families (Open Heart)
- Supporting workforce through coaching and professional development (Strong Backbone)
- Credentialing issue:
  - Program is halted for 1 year (it's supposed to be funded, but it wasn't funded for FY 2025)
  - This is the only training resource directly for child care providers
  - Provides professional development support and bonuses
  - Because of the funding issue, EXCELS is pausing the credentialing pieces, too
  - Chris Peusch is doing an email campaign to the Governor
    - <u>Here</u> is the link to send an email
  - o (Could have asked for Deficiency funding)
  - MSDE credentialing session was today 11:00 am and then two more scheduled for Friday, June 21<sup>st</sup> at 2 pm and Tuesday, June 25<sup>th</sup> at 6 pm
